ORDER:

In the T.O.O. 4th read above, the TSTRANSCO has issued orders for payment of ex-gratia in TS Power Utilities in respect of Non-departmental non-fatal accidents occurred to human beings due to electrocution.

2. The Board of Directors of TSNPDCL in their meeting held on 28.03.2017 accorded approval to adopt the T.O.O 4th read above, for payment of ex-gratia amount in case of Non-Departmental Non-fatal accidents to Human-beings due to electrocution.

3. After careful consideration, TSNPDCL hereby accord approval to adopt the orders issued by TSTRANSCO vide T.O.O.(Jt.Secy-Per)Ms.No.96, Dated. 15.07.2016 for payment of ex-gratia in respect of Non-departmental non-fatal accidents occurred to human beings due to electrocution as follows:

Where permanent total disablement results from the injury:

A fixed amount of Rs. 4.00 lakhs irrespective of age and earning capacity of the injured person.

Note: Since the ex-gratia of Rs. 4.00 lakhs indicated above is for injury in non-fatal accidents resulting in 100% permanent total disablement, the compensation for injury less than 100% shall be calculated to the percentage of loss of earning capacity as certified by a Civil Surgeon.
