In the reference 1st cited, the integrated provisional seniority list of JAOs of NPDCL as on 31-08-2013 was issued duly inviting objections from the concerned, if any, against the said seniority list.

2. Aggrieved by the above, some of the directly recruited JAOs have filed WP No. 15599/2014. The Hon'ble High Court initially through its orders dated 06-06-2014 in W.P.No. 15599/2014 has ordered interim stay of all further proceedings concerning effecting of promotions based on the above provisional Seniority list. However, the said Writ Petition was dismissed on 30-04-2015.

3. Further, subsequent to the issuance of integrated provisional seniority list of JAOs, the Hon'ble High court through its orders dated 22-04-2015 has dismissed the review petitions filed against the Common judgement dated 17-09-2013. The SLPs filed against the said orders and common judgement dated 17-09-2013 were also dismissed by the Hon'ble Supreme Court through its orders dated 23-01-2017. Subsequently, the TSNPDCL vide references 4th, 5th & 16th cited has rescinded the orders issued in NOO 311, Dt. 24-12-2008. Further, the Hon'ble High court has dismissed WP No. 9095/2012 through its orders dated 12-10-2015 duly closing the miscellaneous petitions.

4. During the course of time, certain JAOs have submitted their objections against the integrated provisional seniority list and their placement in the said list. After careful examination of the objections, it is found that there are no valid grounds in their objections as per existing rules, hence the same are not considered and necessary replies were issued to them vide reference 17th cited.

5. The following JAOs have submitted objections/ requested certain modifications in the seniority list which are considered based on the records.

i. Sri Md. Sarwar Mohiuddin, JAO (Sl.No. 24 in the integrated provisional seniority list) of Opn. circle Karimnagar has submitted that even though promotional orders were issued to him on 04-09-2006, but due to administrative delay he was relieved as UDC on 10-10-2006 and joined at the place of posting on 01-11-2006 FN. In view of the above, Sri Md. Sarwar Mohiuddin, JAO has requested to place him in the seniority list at appropriate date duly considering his promotion date. Further, Sri K. Srinivas, JAO (Sl. No. 25 in the integrated Provisional seniority list) of Opn. circle, Karimnagar has submitted his objection that his seniority was fixed at Sl. No.25 below to his juniors in Direct Recruitment due to erroneous commence of probation and requested to rectify his seniority on par with his juniors date by modifying the date of commencement of probation as 17-10-2006.

When their representations were referred to the Superintending Engineer/ Opn./ Karimnagar for examination, the Superintending Engineer/ Opn./ Karimnagar has modified the date of commencement of probation in respect of Sri Md. Sarwar Mchiuddin and Sri K. Srinivas in the cadre of JAO as 08-09-06 FN and 17-10-2006 FN vide reference 11th cited.

ii. Sri U. Rajkumar, JAO (Sl.No. 46 in the integrated Provisional seniority list) has submitted documents with request to incorporate his physical disability particulars in the seniority list.)

iii. Sri G. Gangaram, JAO (Sl.No. 69 in the integrated Provisional seniority list) of Opn. Circle, Nizamabad has request to rectify his date of joining and the date of commencement of probation as 30-06-2008 AN instead of 30-06-2008 FN. The Superintending Engineer / Opn./ Nizamabad has requested vide reference 10th cited to rectify the date of joining and date of commencement of the said JAO as 30-06-2008 AN and 01-07-2008 FN.

iv. Sri A. Nageshwar Rao, JAO (Sl. No. 111 in the integrated Provisional seniority list) of Opn. circle, Nizamabad has requested to modify his date of birth as 02-04-1959 instead of 02-04-1957 and the SE/Op/ Nizamabad has confirmed the same based on the entry in his service register.

v. During the course of time, certain JAOs were promoted as AAOs.

7. Accordingly, the integrated final seniority list of JAOs as on 31-08-2013 (duly making the above modifications and deleting the names JAOs at Sl. No. 17, 110,149 & 158 in the provisional seniority list who have retired from service as on the date of issuance of the said integrated provisional seniority list dated 24-05-2014 and the names of those JAOs/later promoted as AAOs at Sl.No. 6, 50 &126 in the provisional seniority list, who were relieved from TSNPDCL on 10-06-2015 and later reinstated into TSNPDCL as per the directions of Hon'ble High Court) is communicated herewith.

8.- The above integrated final seniority list of JAOs is liable for review, revision as per the outcome of WP No. 16330/2015 & batch and other pending court cases, if any.

9. The CGMs, SEs of Opn. Circle of TSNPDCL are requested to take required No. of copies and communicate to the concerned JAOs (and AAOs whose names are included in the integrated final seniority list) working under their control. They are further requested to display the integrated final seniority list of JAOs of TSNPDCL as on 31-08-2013 in their notice board. The integrated final seniority list is placed in TSNPDCL website at www.tsnpdcl.in.
