**1. Age:** The applicant shall be a retired District Judge or retired Assistant Secretary/Deputy Secretary of Law Department and shall not have crossed the age of 62 years as on the date of publication of notification.

**II. SUBMISSION OF APPLICATIONS:**

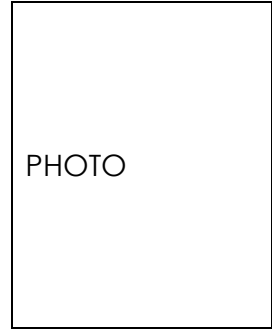
1. The applicants are required to go through the notification and decide themselves as to their eligibility for this recruitment before applying.
