

**Revised Notification for filling the posts of Chairperson in 2 Nos. CGRFs  
(Warangal & Nirmal) in Northern Power Distribution Company of Telangana  
Limited.**

In view of the relaxation given by the Telangana State electricity Regulatory Commission to the proviso under Clause 2.6(a) of Regulation No. 3 of 2015 (Establishment of Mechanism for Redressal of Grievances of the Consumers) vide Lr.No. Tserc/Secy/F.No.IT-30028/3/D.No.86/20, Dt. 11/02/2020, applications are invited from eligible candidates in prescribed proforma for filling up of Two (2) Nos. posts of Chairperson/Consumer Grievances Redressal Forum (CGRF) in Northern Power Distribution Company of Telangana Limited.

The area of jurisdiction of the CGRFs in TSNPDCL is as follows.

**CGRF –I (Warangal):** Erstwhile Combined Operation Circles Warangal, Karimnagar & Khammam consisting of present Warangal (Urban), Warangal Rural, Jangaon, Mahabubabad, Jayashankar Bhupalapally, Karimnagar, Jagtial, Peddapally & Khammam, Bhadradi Kothagudem circles.

**CGRF-II (Nirmal):** Erstwhile Combined Operation Circles Nizamabad & Adilabad consisting of present Nizamabad, Kamareddy, Adilabad, Mancherial, Nirmal & Asifabad circles.

The desirous eligible candidate may submit the application in prescribed format well in advance not later than 05-03-2020 by 5.00 P.M, addressed to Chairman & Managing Director, TSNPDCL, Corporate office, # 2-5-31/2, Vidyuth Bhavan, Nakkalagutta, Hanamkonda, Warangal-506001, Telangana State, India.

**I. Eligibility:**

**1.Age:** The applicant shall be a retired officer, shall have attained a minimum age of 55 years shall not have crossed the age of 62 years as on the date of publication of Notification.

**2.Eligibility Criteria:**

The applicant shall be a retired District Judge or a retired judicial Officer having 20 years of service or a retired Chief Engineer (Electrical/Chief General Manager (Electrical) of Distribution License with 20 years of experience.

### 3.Tenure:

The Chairperson shall hold office for a fixed term of three years or till he attains the age of 65 years whichever is earlier.

The Chairperson shall not be eligible for any extension of term or for re-appointment except for such short periods not exceeding six months as is necessary or expedient, with the prior approval of the TSERC to enable the appointment of successor Members.

### 4.Company Profile:

TSNPDCL was incorporated under the Indian Companies Act, 1956 and is a wholly owned State Government Company. The Company is presently engaged in Distribution and retail supply of electricity.

### 5. Job profile:

The FORUM shall receive the complaints and process the same, shall call for the record, shall be heard in the presence of the complainant and issue necessary orders. The FORUM shall make sittings for hearing the complaints in the Operation Circles under the respective jurisdictions as per the schedule.

### 6. Emoluments:

- i. Consolidated Pay of Rs.1,44,200/- per month (Pay Level 14, Vertical Index number1, in 7<sup>th</sup> CPC)
- ii. **Dearness Allowance:** He will be eligible for DA on par with Govt of India officers as amended from time to time.
- iii. **House Rent Allowance:** He will be eligible for HRA at the place of headquarters on par with Govt. of India officers as amended from time to time
- iv. **Deduction of Pension:** The gross pension (including commutation value) earned by him shall be deducted from the monthly gross salary payable to him.
- v. **Leave:** He will be eligible for causal leave and earned leave as admissible to the serving temporary Telangana State Govt. servant. However, he will not be permitted for earned leave for encashment.
- vi. **TA &DA:** He will be eligible for TA&DA on official tours as applicable under rules of Telangana State Govt.
- vii. **LTC:** He will not be eligible for Leave Travel Concession.
- viii. He will not be eligible for pension and gratuity for the service rendered in the CGRF.
- ix. He will not be eligible for medical reimbursement.
- x. **Vehicle:** He will be provided a vehicle for official use with a limit of 2500 Kms and a monthly hire rate of not exceeding Rs.35,000/-
- xi. **Mobile Charges:** He will be eligible for mobile usage charges of Rs. 15,000/ for each financial year

## **II. SUBMISSION OF APPLICATIONS:**

1. The applicants are required to go through the detailed notification and decide themselves as to their eligibility for this recruitment carefully before applying.
2. The applicants have to submit the application along with enclosures well in advance. Applications received after due date will be rejected. The TSNPDCL will not be responsible for the postal delay.
3. Applicants desiring to apply for both the posts of Chairpersons/CGRF-I & CGRF-II, separate application is to be submitted for each post.
4. Incomplete/in-correct/in-eligible application form will be summarily rejected. TSNPDCL under any circumstances will not entertain the information if any furnished by the candidate subsequently. Applicants should be careful in filling up the application form at the time of submission. If any lapse is detected during the scrutiny, the candidature will be rejected even though he/she comes through the final stage of recruitment process or even at later state
5. The applicants should not furnish any false/tampered/fabricated information or suppress any material information while filling of the application.
6. Mere submission of application and mere attending of interview does not Confer any right on the applicant for appointment to the post of Chairperson/CGRF.

**7. The candidates who have already applied for the post of Chairperson in CGRFs of TSNPDCL as per this office notification dated 22-11-2019, need not apply again.**

**Other Instructions:**

No Person shall be appointed and/or be entitled to continue as a Chairperson or a Member if he/she stands disqualified on account of his/her;

- a. Having been adjudged an insolvent;
- b. Having been convicted of an offence which, in the opinion of the Licensee, involves a moral turpitude.
- c. Having become physically or mentally incapable of acting as such a member;
- d. Having acquired such financial or other interest as is likely to affect prejudicially his/her functions as a Chairperson;
- e. Having so abused his/her position as to render his/her continuance in office prejudicial to public interest;
- f. Having been guilty of proved misbehavior;
- g. Refusal or failure, without reasonable cause to discharge the functions for a period of at least three months; or
- h. Ceases to fulfill any of the conditions of his/her appointment as a Member.

The Northern Power Distribution Company of Telangana State Ltd (TSNPDCL) reserves the right to modify/cancel the Notification and/or Recruitment Process at any stage without assigning any reason.
