With reference to the subject cited, the TS DISCOMS have filed their Aggregate Revenue Requirement and Retail Supply Business for the FY 2016-17 before Hon'ble Commission on 8 <sup>th</sup> March 2016 and public notice was issued on 10 <sup>th</sup> March, 2016. As per the schedule release by the Commission, last date for receipt of Objections / Suggestions is 30 <sup>th</sup> March 2016.	The issue is not under purview of the Licensee.
2.	This is to bring to your kind notice that as per the schedule released by the TSERC only three weeks time (8 <sup>th</sup> March to 30 <sup>th</sup> March 2016) is given for filing Objections / Suggestions on ARR and Retail Supply Business including Cross Subsidy Surcharge and Additional Surcharge for Open Access consumers FY 2016-17.	
3.	As per the rules minimum of 30 days is to be given to file the Objections and 45 days for conducting Public Hearing on the ARR filings. Hence, we request you to extend the last date for filing objections from <b>30<sup>th</sup> March to 8<sup>th</sup> March 2016</b> , giving 30 days time to the stakeholders.
