The Contract Agencies/ Contractors who are willing to participate in Tenders for the above work should have to fulfil the following Technical & Financial qualifications.

**A.) Technical Qualifications:** 1) valid 'A' Grade License (not below the voltage level of 33KV) issued by the Telangana Electrical Licensing Board. 2) Valid Registration with TSNPDCL. 3) Valid Labour License, issued by concerned area Labour Commissioner/Officer for the no.of labour which the contractor will be engaged for the work. 4) The Tenderer should have EPF Registration number. 5) If the Tenderer is one of the partner of any Partner Ship firm or authorized representative of the firm then such tenderer has to furnish registered partnership deed and Form 'C' issued by Registrar of firms and an affidavit/ power of attorney of partners, describing their authorized person's role & activities clearly and stating that they have responsible/ answerable for all the acts/ deeds carried out by their authorized person. 6) **Experience:**-Should have experience in similar nature of works, at least 50% quantity of work to be tendered. Dismantling of 0.65KM of 33KV line and 0.24KM 11KV Line, 0.05KM LT line & Erection of 0.21 33KV line, 0.75 11KV line, 0.05LT/ 3-Ph 5-Wire line, 4Nos M+6 Towers are involved in the work. (Experience & Performance should be certified by Concerned Divisional Engineer). The tenderer has to furnish proof for quantity of work done as desired in the tender notice.

**B) Financial Qualifications:**1) The tenderer shall have achieved a minimum annual financial Turnover of 50% of Tender value in any one of previous five years & the tenderer has to furnish proof of Turn Over, duly Certified by Auditors for previous 5years or from the year of entering into contracts along with IT Returns).

2) The tenderer has to furnish Bank DD or 2% of ECV (Estimated Contract Value) along with tender unless the tenderer is having exemption within the value of work, to be tendered.3)The tenderer should produce the Valid PAN Card, AADHAR CARD, GST Registration.


**C) Tenderer should enclose attested Xerox copies of relevant documents/Certificates pertaining to the above mentioned Technical & Financial Qualifications for proof & firm name should be the same in all certificates & documents furnished. Otherwise the tender will be rejected without any consideration.**
