**II. Other conditions:**

1. The Tenderer are permitted to bid any number of works for carrying out work in operation circle. But only 1 contract will be awarded to that contractor in a circle.
2. The maximum value of the bid is Rs.20/- lakhs for each agency .
3. If bidder is successful in more than one contract only 1 contract will be awarded as per choice of successful bidder.
4. As it is the Rate contract, the DE/Operation has to award specific works as per the necessity.
5. The Contractor shall be from same district/Local Area.

**III. Evaluation of Bids:**

1. If more than one bidders quotes same price (i.e. L1 price) the successful bidder will be decided through **Negotiations with the discretion of management.**
2. Only **one contract** will be awarded to **one bidder** in the entire Circle.

**IV. Contractor Overheads and profit including Labour Importation**

1. The allowable Contractor Overheads and profit including Labour Importation charges shall not be more than +5.0 %. To -10%
2. The security deposit shall be paid in the form of Demand Draft which will be deposited in the account of utility. No interest shall be payable on such amount by utility to bidder.

**V. Reservation for SC & ST Contractors.**

1. 15% of 39Nos Operation Sections i.e., 6No Operation Sections are reserved for both SCs & STs. Eligible SC & ST bidders participated in the tender will be considered for allotment of work. As per 2011 census 4nos. sections are reserved for SCs and 2nos. sections are reserved for STs.
2. Reserved sections for SC bidders are as following.  
A) Vemsoor

3.If no eligible SC bidders quotes/ participated in the tender (reserved for SCs), the tender will be cancelled and same will be taken up under open category for that period.

**VI). Tender Schedule of Rates:**

1. **Labour Portion:** As per the Circle Standard Schedule of Rates (SSR) to be adopted.
2. **Material portion:** As per the SAP prices to be adopted.
