The Contract Agencies/Contractors, who are willing to participate in Tenders for the above works, should have to fulfil the following Technical & Financial Eligibility criteria.

A.) Technical Qualifications:

- 1) valid 'A' Grade License (not below the voltage level of 33KV) issued by the Telangana Electrical Licensing Board.
- 2) Valid Registration with TSNPDCL.
- 3) Previous experience in similar nature of works since past Five years.
- 4) Labor License in form-VI, issued by concerned area Labor Commissioner/Officer for the no.of labor which the contractor will be engaged for the work.

B) Financial Qualifications:

- 1) The tenderer shall have achieved a minimum annual financial turnover of 50% of Tender value i.e., Rs.10/-Lakhs.
- 2) The Tenderer should produce the Valid PAN Card, valid registration with Central Customs & Excise Department and also TIN & TAN Number.
- 3) Should have GST Registration.
- 4) Should have EPF registration No.
- 5) Should have AADHAR CARD & Address proof.

C) General Qualification:

- 1) Minimum 3 Bids are required to open tender.
- 2) Tenderer has to submit Form-16 /Form-26AS to verify the financial Turn Over.
- 3) Bid Security of Rs.40,000/- (2% of Tender Value) in the form of DD, in the name of A.O/Expr., Circle Office.
- 4) The Tenderer shall be from the same District/Local Area.

Evolution of Bids.

1. If more than one bidders quotes same price (i.e., L1 price) the successful bidder will be decided with the financial Turn Over of the tenderer. And finally through Negotiations with the discretion of management tender will be finalized.

D) Tenderer should enclose attested Xerox copies of relevant documents/Certificates pertaining to the above mentioned Technical & Financial Qualifications for proof. Otherwise the Bid Security furnished by the Tenderer/ Contractor shall be confiscated. If such Tenderer is having exemption from Bid Security, then the Tenderer will not be allowed for participating in Tenders for one year. Tenderer belonging to SC/ST individuals are exempted from payment of Bid Security at the time of submission of tender.
