Technical Qualification :

1. Should Have 'A' Grade Licence
(Not Below The Voltage Level Of 33 Kv)
2. Should Have TSNPDCL Valid Registration/Sap Vendor Number.
3. Should have Experience in Erection of 33kv/11kv/6.3kv /LT Lines & DTRs, Energy Meters Etc...(Experience & Performance Should Be Certified By Divisional Engineer/Opn.)

Financial Qualification

1. Should have achieved minimum Financial Turnover of Rs.4,00,000/- in execution of 33kv/11kv/6.3kv /LT Lines & DTRs Work in any **consecutive 12 months** in last five years period and the same shall be certified by the Divisional Engineer /Operation.
2. Should have Pan Card
3. Should have Aadhar Card/Address proof
4. Should have GST Registration Number

General

1. Minimum three bids are required to open the Tender
2. Should Have Labour License in Form-VI Issued By Concerned Area Labour Commissioner/Officer For The No.Of. Labours For Which The Tenderer Will Be Engaged For The Work.
3. Should Have EPF Registration Number

4. Should Submit **Income Tax Clearance Certificate /Income Tax Return Copy Before First Billing** Failing Which The Bill Will Not Be Released

5. Bid Security will be forfeited if the bidder do not turn up for agreement with in 15 Days from the date of issue of Letter of Acceptance

II. Other conditions:
