The tender works shall have to fulfill the following Technical & Financial eligibility criteria.


**A) Technical Qualifications:** 1) valid 'A' Grade License (not below the voltage level of 33KV issued by the Telangana Electrical Licensing Board. 2) Valid Registration with TSNPDCL. 3) previous experience in similar nature of works. 4) Valid Labour License, for the no.of labour which the contractor will engage for the work. 5) The Tenderer should have EPF Registration number. 6) Group Insurance for the labour used in the work.

**B) Financial Qualifications:** 1) The Tenderer shall have achieved a minimum annual financial Turnover of 50% of Tender value. 2) The Tenderer have to furnish Bank DD for 2% of ECV (Estimated Contract Value) along with tender unless the tenderer is having exemption within the value of work, to be tendered (caste certificate shall be enclosed). 3) The Tenderer should produce the Valid PAN Card, valid registration with Central Customs & Excise Department.

**C)** Tenderer should enclose Xerox copies of relevant documents/ Certificates pertaining to the above mentioned Technical & Financial Qualifications for proof. Otherwise the Bid Security furnished by the Tenderer/Contractor shall be confiscated. If such Tenderer is having exemption from Bid Security, then the Tenderer will not be (debarred) for participating in Tenders for one year.
