**Circular Memo.No.Sub-Committee/TS Power Utilities/C.No.01/2019-1, Date :06.09.2019**

Sub:- Estt. – TS Power Utilities – Bifurcation of State Cadre Employees between TS & AP Power Utilities – Options – Called for.

In the reference 1<sup>st</sup> cited, the Hon'ble Supreme Court was pleased to appoint Hon'ble Mr. Justice D.M. Dharmadhikari, former Judge of Hon'ble Supreme Court of India, as One Man Committee, to determine the Modalities for distributing the personnel (i.e.)the 1157 Employees. In case dispute persists in respect of other employees of these Power Utility Companies of the two states, it would be open to the respective States/Power Utility companies to bring the same before the said Committee.

2. In the reference 2<sup>nd</sup> cited, Hon'ble Mr. Justice D.M. Dharmadhikari, former Judge of Hon'ble Supreme Court of India, One Man Committee has appointed a Sub-Committee consisting Sri. S. Ashok Kumar, Director (HR)/TSGENCO as a Member on behalf of Telangana State Power Utilities and Sri. G. Adinarayana, Director (Finance & Comml.)/APGENCO as a Member on behalf of AP Power Utilities. Subsequently, the Managing Director/APGENCO has nominated Sri. B.A. Mohan Rao, Director (HR& IR)/APGENCO as the Member of Sub-Committee in place of Sri. G. Adinarayana, the then Director (Finance & Comml.)/APGENCO. The One Man Committee has also framed Final Modalities for allocation of the Personnel between the TS & AP Power Utilities. The Sub-Committee was directed to call for Options from all the State Cadre Employees of the rank of AE and equivalent cadres and above and all employees working at Head Quarters of TSGENCO, TSTRANSCO, TSSPDCL and TSNPDCL.

3. In the reference 3<sup>rd</sup> cited, the One Man Committee on 30.08.2019, directed the Sub-Committee of TS Power Utilities to call for the Options from all the State Cadre Employees working in TS Power Utilities including 41 Employees who have not exercised the Options earlier as per the Interim Orders Dtd: 03.11.2017 in W.P.No.16330/2015 & Batch of the Hon'ble Division Bench for the State of Telangana and for the State of Andhra Pradesh. ***The Employees who have exercised their Options earlier in terms of the order Dtd: 03.11.2017 of the Hon'ble Division Bench of High Court at Hyderabad as stated supra, are not entitled to exercise Options now being called for.***

4. (i) Therefore, all the State Cadre Employees who are on rolls as on 02.06.2014 in the rank of AE and equivalent cadres and above and all employees working at Head Quarters of TSGENCO, TSTRANSCO, TSSPDCL & TSNPDCL, including 41 Employees who have not exercised option earlier in terms of the order Dtd:03.11.2017 of the Division Bench of Hon'ble High Court and also the 229 employees who were self-relieved from AP Power Utilities and joined in TS Power Utilities are requested to exercise their option in the format appended to this order and submit in the respective ***O/o Director (HR)*** of TS Power Utilities, duly countersigned by the concerned Functional Head/Station Head/Zonal Chief Engineer/Superintending Engineer.

(ii) The state cadre employees who have exercised their options in terms of the orders Dtd: 03.11.2017 in WP.No: 16330 of 2015 of The Hon'ble High court at Hyderabad are not entitled to exercise options now called for.

(iii) The Assistant Engineers recruited under Zonal System of recruitment are not entitled to exercise options.

5. The State Cadre Employees who have Retired from service on attaining the age of superannuation or died after 02.06.2014, the Pensioner/Family Pensioner shall also be required to exercise their Option either to TS or AP Power Utilities as ordered in para 4 above.

6. All the State Cadre Employees mentioned in para 4 above are requested to exercise their Option through online mode using respective ESS Portal/DISCOMS Website. They are also directed to download and submit scanned copy of their Option Forms after counter signature of the functional head / station head in addition to the hard copy to the concerned **E-mail ID**, along with supporting documents, if any.

7. The Option Form will be available in respective ESS Portal/ DISCOMS Website with effect from 06.09.2019 and the last date for exercising the Option and submission of the Option form shall be on or before 20.09.2019, 05.00 PM in the respective Offices of Director (HR).

8. The Option exercised by them is final and they are not allowed to revise their option under any circumstances whatsoever. If any of the State Cadre Employee, Pensioner/Family Pensioner fails to exercise their Option shall be deemed to be the Employee/Pensioner/Family Pensioner of AP Power Utilities.
