ORDER:-

Government of Telangana have enacted Telangana State Industrial Project Approval and Self - Certification System - TS-iPASS Act 3 of 2014 and towards it, notified that every electrical installation of voltage upto 650V shall be inspected, tested and shall be self- certified by the owner of the installation before commencement of supply or recommencement after shut down for six months and above for ensuring observance of safety measures specified under regulation 30 and 43 of Central Electricity Authority (Measures relating to Safety and Electrical Supply) and as per Business Reform Action Plan under Ease of Doing Business vide G.O. 1st read above. Provided further that every electrical installation covered under section 54 of the Electricity Act, 2003 shall be inspected and tested by the Electrical Inspector.

2. Government have issued orders to complete the process of Electrical Design approval within 14 days and to complete the process of Electrical Installation Certificate within 14 days for electrical installation of voltage exceeding 650V under regulation of 43 of Central Electricity Authority (Measures relating to safety and electric Supply) Regulations, 2010 to provide speedy processing for issue of approvals, certificates for setting up industries and also to provide investor friendly environment in the state of Telangana as per Business Reform Action Plan under Ease of Doing Business, vide G.O. 2nd read above.

3. Business Reform Action Plan, 2019, Recommendation No. 50 stipulates that the charged electrical connections (for all voltages - Low/High/Extra High Tension) along with Chief Electrical Inspector (CEIG) approval (wherever required) shall be provided within:

- i. Seven days (where no 'Right of Way' (RoW) is required).
- ii. Fifteen days where RoW is required from concerned agencies"

4. Government after careful examination hereby issue the following notification prescribing the revised timelines for issuing the Electrical Installation Certificate by Chief Electrical Inspector to Government for Electrical Installations of exceeding 650V.

NOTIFICATION

1. The State Government hereby notifies that, the Electrical Installation certificates for Electrical Installations of exceeding 650V shall be issued by Telangana Electrical Inspectorate Department within 6 days instead of 14 days irrespective of Right of Way or No Right of Way to fulfil the Recommendation No. 50 of Business Reform Action Plan, 2019 under Ease of Doing Business.

The revised timelines are given below.

- I. Pre-scrutiny of Applications received in full shape towards Electrical Installation Certificate shall be completed within 1 working day from date of submission of Application.
 - II. Inspection of Installation shall be conducted by the concerned officer within 3 working days after receipt of fee payment towards Electrical Installation Certificate.
 - III. Form of Order shall be issued within 1 working day after the date of inspection.
 - IV. Electrical Installation Certificate shall be issued within working day after the receipt of satisfactory compliance report.
2. The Chief Electrical Inspector to Government of Telangana, Hyderabad shall take further action accordingly.
