

**Notification for filling the post of Chairperson/
Consumer Grievances Redressal Forum-I / Warangal
in Northern Power Distribution Company of Telangana Limited.**

Applications are invited from eligible candidates in prescribed proforma for filling up the post of Chairperson/Consumer Grievances Redressal Forum-I (CGRF-With HQs at Warangal) in Northern Power Distribution Company of Telangana Limited.

The area of jurisdiction of the CGRF-I/ Warangal in TSNPDCL is as follows.

CGRF –I (Warangal): Consisting of Opn. circles, Hanumakonda, Warangal, Jangaon, Mahabubabad, Jayashankar Bhupalapally (including Mulugu District), Karimnagar, Peddapally, Khammam & Bhadradi Kothagudem.

The desirous eligible candidate may submit the application in prescribed format well in advance not later than 15-05-2023 by 5.00 P.M, addressed to Chairman & Managing Director, TSNPDCL, Corporate office, # 2-5-31/2, Vidyuth Bhavan, Nakkalagutta, Hanamkonda, Warangal-506001, Telangana State, India.

I. Eligibility:

1.Age: The applicants should have attained a minimum age of 55 years and shall not have crossed the age of 62 years as on the date of publication of Notification.

2.Eligibility Criteria:

The applicant shall be:-

(i) a retired District Judge or a retired Judicial Officer having 20 years of service;

(OR)

(ii) a retired Chief Engineer (Electrical) /Chief General Manager (Electrical) of a Distribution/Transmission Licensee having 20 years of experience;

(OR)

(iii) a retired Chief General Manager (Accounts Services) of a Distribution Licensee having 20 years of experience.

3.Tenure:

The Chairperson shall hold office for a period not exceeding three (3) years or till attaining the age of 65 years, whichever is earlier and shall not be eligible for any extension of term except for such period not exceeding six(6) months as is necessary or expedient to enable the appointment of successors.

4. Company Profile:

TSNPDCL was incorporated under the Indian Companies Act, 1956 and is a wholly owned State Government Company. The Company is presently engaged in Distribution and retail supply of electricity.

5. Job profile:

The FORUM shall receive the complaints and process the same, shall call for the record, shall be heard in the presence of the complainant and issue necessary orders. The FORUM shall make sittings for hearing the complaints in the Operation Circles under the respective jurisdictions as per the schedule.

6. Emoluments:

- i. Consolidated Remuneration @ Rs.1,20,000/- per month without linking to the Pension drawn by them and with 10% annual enhancement cumulative, without entitlement of any Dearness Allowance and House Rent Allowance.
- ii. **Leave:** He/She will be eligible for causal leave and earned leave as admissible to the serving temporary Telangana State Govt. servant. However, he/she will not be permitted for earned leave for encashment.
- iii. **TA & DA:** He/She will be eligible for TA&DA on official tours as applicable under rules of Telangana State Govt.
- iv. **LTC:** He/She will not be eligible for Leave Travel Concession.
- v. He/She will not be eligible for pension and gratuity for the service rendered in the CGRF.
- vi. He/She will not be eligible for medical reimbursement.
- vii. **Vehicle:** He/She will be provided a vehicle for official use with a limit of 2500 Kms and a monthly hire rate of not exceeding Rs.35,000/-
- viii. **Mobile Charges:** He/She will be eligible for mobile usage charges of Rs. 15,000/ for each financial year

II. SUBMISSION OF APPLICATIONS:

1. The applicants are required to go through the detailed notification and decide themselves as to their eligibility for this recruitment carefully before applying.
2. The applicants have to submit the application along with copies of supporting documents well in advance. Applications received after due date will be rejected. The TSNPDCL will not be responsible for the postal delay.
3. Incomplete/in-correct/in-eligible application form will be summarily rejected. TSNPDCL under any circumstances will not entertain the information if any furnished by the candidate subsequently. Applicants should be careful in filling up the application form at the time of submission. If any lapse is detected during the scrutiny, the candidature will be rejected even though he/she comes through the final stage of recruitment process or even at later state

4. The applicants should not furnish any false/tampered/fabricated information or suppress any material information while filling of the application.
5. Mere submission of application and mere attending of interview does not Confer any right on the applicant for appointment to the post of Chairperson/CGRF.

III. CHECK LIST:

Note: Applicants satisfying the eligibility criteria will be shortlisted and shall be called for to attend the interview.

Other Instructions:

No Person shall be appointed and/or be entitled to continue as a Chairperson or a Member if he/she stands disqualified on account of his/her;

- a. Having been adjudged an insolvent;
- b. Having been convicted of an offence which, in the opinion of the Licensee, involves a moral turpitude.
- c. Having become physically or mentally incapable of acting as such a member;
- d. Having acquired such financial or other interest as is likely to affect prejudicially his/her functions as a Chairperson;
- e. Having so abused his/her position as to render his/her continuance in office prejudicial to public interest;
- f. Having been guilty of proved misbehavior;
- g. Refusal or failure, without reasonable cause to discharge the functions for a period of at least three months; or
- h. Ceases to fulfill any of the conditions of his/her appointment as a Member.

The Northern Power Distribution Company of Telangana State Ltd (TSNPDCL) reserves the right to modify/cancel the Notification and/or Recruitment Process at any stage without assigning any reason.
